RESOLUTION NO. 2012-36

**A RESOLUTION LEVYING GENERAL PROPERTY TAXES FOR THE TAX YEAR 2013
TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE TOWN OF
NEDERLAND, COLORADO, AND THE NEDERLAND DOWNTOWN DEVELOPMENT
AUTHORITY FOR THE 2013 BUDGET YEAR BEGINNING ON THE FIRST DAY OF
JANUARY 2013 AND ENDING ON THE LAST DAY OF DECEMBER 2013**

WHEREAS, the Board of Trustees has adopted the annual budget in accordance with the Local Government Budget Law, on December 4th, 2012

WHEREAS, the amount of money necessary to fund the Town of Nederland budget for general operating purposes including bonds and interest, is \$1,156,739 and the amount of money necessary to fund the Nederland Downtown Development Authority budget, is \$913,953, and

WHEREAS, the 2012 net assessed valuation for the Town of Nederland as certified by the Boulder County Assessor is \$21,445,584 and the 2012 assessed valuation of the Nederland Downtown Development Authority as certified by the Boulder County Assessor is \$4,862,710.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Town of Nederland, Colorado:

SECTION 1. Adoption of Mill Levy for the Town of Nederland

For the purpose of meeting all general operating expenses of the Town of Nederland during the 2013 budget year, there is hereby levied a gross mill levy of 17.274 mills upon each dollar of the total valuation for assessment of all taxable property within the Town of Nederland for the year 2012. A one-year temporary credit of 0.357 mills is hereby approved, resulting in a net effective mill levy of 16.917 mills upon each dollar of the total valuation for assessment of all taxable property within the Town of Nederland for the year of 2012. The mill levy approved herein is not in excess of the amount levied for 2012 in accordance with Article X, Section 20 of the Colorado Constitution (TABOR).

SECTION 2. Adoption of Mill Levy for the Nederland Downtown Development Authority

For the purpose of meeting all Nederland Downtown Development Authority expenses during the 2013 budget year, there is hereby levied a gross mill levy of 5.0 mills upon each dollar of the total valuation for assessment of all taxable property within the Nederland Downtown Development Authority District within the Town of Nederland for the year 2012. The mill levy approved herein is not in excess of the amount levied for 2012 in accordance with Article X, Section 20 of the Colorado Constitution (TABOR).

SECTION 3. The Town Clerk is hereby authorized and directed to immediately certify the above mill levies for the Town of Nederland and Nederland Downtown Development Authority to the Boulder County Commissioners.
