RESOLUTION 2013 - 02

A RESOLUTION OF THE NEDERLAND BOARD OF TRUSTEES ADOPTING THE NEDERLAND AREA PARKS, RECREATION, OPEN SPACE AND TRAILS MASTER PLAN AND ENCOURAGING THE FORMATION OF A PARKS AND RECREATION SPECIAL DISTRICT THAT INCLUDES THE TOWN OF NEDERLAND

WHEREAS, pursuant to C.R.S. § 31-23-206(1)(b), the Town of Nederland (“Town”) Board of Trustees (“Board”), upon the advice and consult of the Town Planning Commission, possesses the authority to adopt a master plan for the physical development of the Town, including a plan for the general location of public places and facilities, including parks, playgrounds, squares and other public ways, grounds, open spaces and trails; and

WHEREAS, pursuant to Town Resolution 2010-24, adopted on October 19, 2010, the Board outlined as part of the mission of the Parks, Recreation, and Open Space Advisory Board (PROSAB), the maintenance of a master plan related to such public places and facilities; and

WHEREAS, on September 25, 2001, the Board adopted the original *Town of Nederland and Surrounding Areas Open Space, Trails, Parks and Outdoor Recreation Master Plan*; and

WHEREAS, on July 5, 2011, recognizing the need to update said 2001 Plan, the Board accepted a grant award to help fund and support an update to the Plan and the Gateway Park Concept Plan project; and

WHEREAS, the Town has prepared an updated Plan, called the Nederland Area Parks, Recreation, Open Space and Trails Master Plan (PROST Master Plan); and

WHEREAS, the PROST Master Plan was developed and reviewed through the Nederland Planning Process (NPP) involving numerous public meetings and workshops before Town boards and commissions including the Planning Commission, PROSAB, Community Center Foundation Board, Downtown Development Authority, and the project Steering Committee, and at such public meetings interested parties were provided the opportunity to review, comment and provide input on the Plan; and

WHEREAS, after consideration of all input from the public, its professional consultants and advisory boards, commissions and staff, the Board now wishes to adopt the PROST Master Plan, as presented and attached to this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF NEDERLAND, COLORADO:

Section 1. The Board of Trustees hereby adopts the Nederland Area Parks, Recreation, Open Space and Trails Master Plan, attached hereto and incorporated herein by this reference, including all attachments and appendices thereto.

Section 2. The Board of Trustees finds and determines that the PROST Master Plan can likely only be fully realized with the establishment of a parks and recreation special district, as recommended

in the Plan. The Board therefore expresses its support for and encouragement of the formation of such a district that includes the Town of Nederland.

Section 3. This Resolution shall take effect immediately upon adoption.
