**RESOLUTION NO. 2016-34**

**A RESOLUTION LEVYING GENERAL PROPERTY TAXES FOR THE TAX YEAR 2017  
TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE TOWN OF  
NEDERLAND, COLORADO, AND THE NEDERLAND DOWNTOWN DEVELOPMENT  
AUTHORITY FOR THE 2017 BUDGET YEAR BEGINNING ON THE FIRST DAY OF  
JANUARY 2017 AND ENDING ON THE LAST DAY OF DECEMBER 2017**

**WHEREAS,** the Board of Trustees has adopted the annual budget in accordance with the Local Government Budget Law, on December 6, 2016; and

**WHEREAS,** the amount of money necessary to fund the Town of Nederland budget for general operating purposes including bonds and interest, is \$1,809,705 and the amount of money necessary to fund the Nederland Downtown Development Authority operating budget, is \$771,206; and

**WHEREAS,** the 2016 net assessed valuation for the Town of Nederland as certified by the Boulder County Assessor is \$22,879,501 and the 2016 combined base and incremental assessed valuation of the Nederland Downtown Development Authority as certified by the Boulder County Assessor is \$6,185,121.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE  
TOWN OF NEDERLAND, COLORADO**

**SECTION 1. Adoption of Mill Levy for the Town of Nederland**

For the purpose of meeting all general operating expenses of the Town of Nederland during the 2017 budget year, there is hereby levied a gross mill levy of 17.274 mills upon each dollar of the total valuation for assessment of all taxable property within the Town of Nederland for the year 2016. The mill levy approved herein is not in excess of the amount levied for 2016 in accordance with Article X, Section 20 of the Colorado Constitution (TABOR).

**SECTION 2. Adoption of Mill Levy for the Nederland Downtown Development Authority**

For the purpose of meeting all Nederland Downtown Development Authority expenses during the 2017 budget year, there is hereby levied a gross mill levy of 5.0 mills upon each dollar of the total valuation for assessment of all taxable property within the Nederland Downtown Development Authority District within the Town of Nederland for the year 2016. The mill levy approved herein is not in excess of the amount levied for 2016 in accordance with Article X, Section 20 of the Colorado Constitution (TABOR).

**SECTION 3.** The Town Clerk is hereby authorized and directed to immediately certify the above mill levies for the Town of Nederland and Nederland Downtown Development Authority to the Boulder County Commissioners.
