### 1. NedCompost Update

**Discussion:** Jesse Seavers discussed NedCompost. Financial viability at 16 paying customers at \$8/month. Need electricity for the Earth Tubs, but Town staff has found a low(no)-cost solution. Holding off on PR until electricity is ready. Need members to serve on the NedCompost board. Group may expand into recycling.

**Action Item:** Recruit board members for NedCompost.

### 2. Sustainability Action Plan Brainstorm

**Discussion:** Dallas Masters requested that the SAB regroup after numerous recent and varied requests and begin by laying out our topic areas for the Sustainability Action Plan. He suggested we start with the [DOLA Sustainability Self Assessment](#) that Trustee Mueller advised. The group went through the list of topics in the document and consolidated the topics and assigned point people based on expertise and interest to lead each topic:

The group discussed that each point person will now lead any future discussions and field requests on their particular topics so that we can work efficiently and without overlap. meeting. The group also agreed to read the other documents provided by Trustee Mueller and James Wood of Boulder County ([UW Community Sustainability Toolkit](#), [James Wood Best Practices](#), [Fort Collins Sustainability Plan](#)) and come prepared to begin the Nederland Sustainability Action Plan process.

**Action Item:** Conduct self-assessment, read all documents, and come prepared to outline the process for developing the Nederland Sustainability Action Plan.

### **3. Zero Waste Action Plan**

**Discussion:** The BOT has requested that the SAB begin developing an implementation plan for the Nederland Zero Waste Action Plan since the BOT recently adopted the Boulder County version.

**Action Item:** Jesse Seavers is leading waste management, so he volunteered to prepare an outline of our implementation plan for the next meeting to begin the process.

### **4. Other Business**

#### **SAB Positions**

**Discussion:** Jesse Seavers suggested that the group should change the chair, vice-chair, and secretary positions since the group has new members. The group voted to elect Dallas Masters as chair, Greg Willson as vice-chair, and Geneva Mixon as secretary.

**Action Item:** Dallas Masters will draft a working agreement on agenda setting, meeting procedure, and minutes.
