The Town of Nederland reserves the right to limit or discontinue rebate funding as is necessary. Only residential customers with active utility accounts in good standing are eligible. Purchase must be made before 4/15/2016. Rebate forms will be accepted on a first come, first served basis at Town Hall until 4/25/16 or until funds run out, whichever comes first. Section 2: Rebate Information - High Efficiency Toilet

Reimbursement (up to \$200 for eligible toilets) will be paid for the actual cost of the toilet only (we will not be able to cover tax or installation).

A) Only EPA WaterSense® approved toilets are eligible for this rebate. Similarly, only WaterSense® approved dual-flush toilets are eligible for rebate. WaterSense® approved toilets are high-efficiency toilets (HET) which are rated to use **1.28 gpf or less**.
