2. Fiscal irresponsibility of taxpayer and grant monies, lack of oversight of planned and partially implemented projects;
3. Mismanagement of Guercio Memorial Ballpark, including it's use as a parking lot;
4. Incomplete and hard to access public record and Town website;
5. Town boards operating contrary to Sunshine Laws, charter/by-laws, public record requirements, inconsistent procedure for board appointment, and denying due process;
6. Inconsistent recusal process, nepotism;
7. Lack of oversight of public works, enabling sloppy and deferred maintenance of our infrastructure including roads and sidewalks, which pose threat to public safety;
8. Ignoring legitimate public concerns, scientific data and economics when considering projects such as annexations, banning/limiting STR's, ADU's/density, clear cutting, traffic flow, emergency access, infrastructure and road maintenance, requiring costly, temporary fixes to address what become emergency matters.
